We write on behalf of Defendants KalshiEX LLC, Kalshi Inc., Kalshi Klear LLC, Kalshi Klear Inc., and Kalshi Trading LLC (“Defendants”) to request the Court to adjourn the January 7, 2026 Initial Pretrial Conference, and all associated deadlines, including the parties’ obligation to file a proposed Civil Case Management Plan.
